Boxers, coaches, club members and supports, must always show respect and courtesy to tournament officials, stewards, referees/judges and staff. **The decisions of our officials must be respected.**

No boxer, coach, club member or support has the right to act in a disrespectful fashion towards our officials during or after a contest, this includes the posting of derogatory comments on social media sites.
